1. INTRODUCTION

S.P.Im. S.p.A. is a company wholly owned by the Municipality of Genoa in charge of managing the process of valuation and sale of the available municipal assets, acquired and sold on the basis of sales programs established by the latter.

In this context, S.P.Im. S.p.A. intends to proceed with the valuation and sale of the buildings referred to as the former "exhibition grounds", including the properties owned by the Administration following the receipt of expressions of interest, as specified below.

Arch. Renzo Piano and the Renzo Piano Building Workshop S.r.l. have produced an outline design, called "Waterfront di Levante", donated to the Municipality of Genoa, the Liguria Region and the Port Authority of the Western Ligurian Sea. The outline design was subsequently updated by Arch. Renzo Piano in the light of the indications for the development of the design made by the Superintendent competent in matters of landscape and cultural heritage.

The Municipality of Genoa accepted this donation by resolution of the City Council no. 253 of 28 October 2017, and subsequent deed of gift on 31 October 2017.

The company Nuova Foce S.r.l., wholly owned by the company S.P.Im. S.p.A., in turn wholly owned by the Municipality of Genoa, together with the latter, are the owners of the real estate compendium in the Municipality of Genoa affected by the Waterfront of Levante, and better indicated in the Disciplinary of tender relating to this procedure of expression of interest.

S.p.A., as owner of the entire share capital of Nuova Foce s.r.l., as well as agent representing the Municipality of Genoa, for the buildings and rights of the Municipality of Genoa, as specifically indicated in the tender regulations.

2. ADMITTED PERSONS AND SELECTION PROCEDURE

Subjects admitted

Economic operators, natural or legal persons, public entities, groupings of such persons or entities, including any temporary association of companies or professionals, or bodies without legal personality who possess the requisites provided for by the Rules of the tender may participate in the selection procedure, if they do not fall under one of the causes of exclusion indicated in Annex I to the Tender regulations and are in possession of the subjective requisites provided for therein.

Stages of the procedure
